By accepting possession of the Isle of Wight County Schools-issued tablet/computer device ("device"), I understand that I am also accepting the following responsibilities for the use and care of this device. I understand the following:

- The device is property of Isle of Wight County Schools (IWCS)
- The device is subject to inspection and search at any time by school employees.
- I am always accountable for my child's device and take full responsibility for all damages or loss.
- I will ensure proper care of my child's device. Steps I will take to care for the device include, but are not limited to, keeping device in the protective case that is provided by IWCS at all times, avoiding food and beverages near the device, preventing damage from sharp objects, and not removing or altering the IWCS barcode or device serial/manufacture numbers.
- The device must not be left unattended at any time or used near water.
- I will not loan my device, charger, case, cords or other accessories to any other individual.
- I am not to delete or alter any school installed application or software on the device.
- I am to always follow the IWCS Acceptable Use Policy.
- I will ensure my child brings the device to school fully charged each day.
- I will report any damage, theft, loss or vandalism to school administration immediately.
- I must report any knowledge of inappropriate use of my device to a school designee.
- I agree to return the device, case, charger, power cord(s), and any other accessories issued to me in connection with the device in good working condition at the end of the school year, upon leaving IWCS or when my user privileges are revoked.
- I will ensure my child understands and abides by these responsibilities for the use and care of the device.

_____ I grant permission for my child to be issued an IWCS device. I understand that by granting permission, my child may be transporting the device to and from school and I am responsible for all supervision of internet safety usage outlined in the IWCS Acceptable Use Agreement Policy and Regulation IIBEA/GAB and IIBEA-R/GAB-R and the School Code of Conduct. Upon completion of the current academic year or student withdrawal from the school, you have a maximum of 7 days to return the technology device. After the 7 days have expired, the technology device may be considered stolen, and the issue may be turned over to law enforcement.

Protection Information – PLEASE READ AND INITIAL

Isle of Wight County Schools has partnered with Worth Avenue Group and AGI Repair, Inc to offer insurance protection plan options for the device. Both plans will cover the full cost of accidental damage to the loaned device. Worth Avenue Group is considered a full protection plan covering loss, theft, fire and accidental damage. AGI insurance is an accidental damage plan only. Please note that intentional damage, misuse, abuse, or unreported loss may not be covered under either insurance plan. In such cases, the student and parent/guardian may still be held fully responsible for the cost of repair or replacement.

_____ I understand that I will be responsible for paying any fees related to the loss of or major damage to the device, charger, cord and/or case at the current replacement rates from Apple/Dell/HP (www.apple.com / www.dell.com / www.hp.com) unless an insurance plan has been purchased and the damage is covered under that plan.
